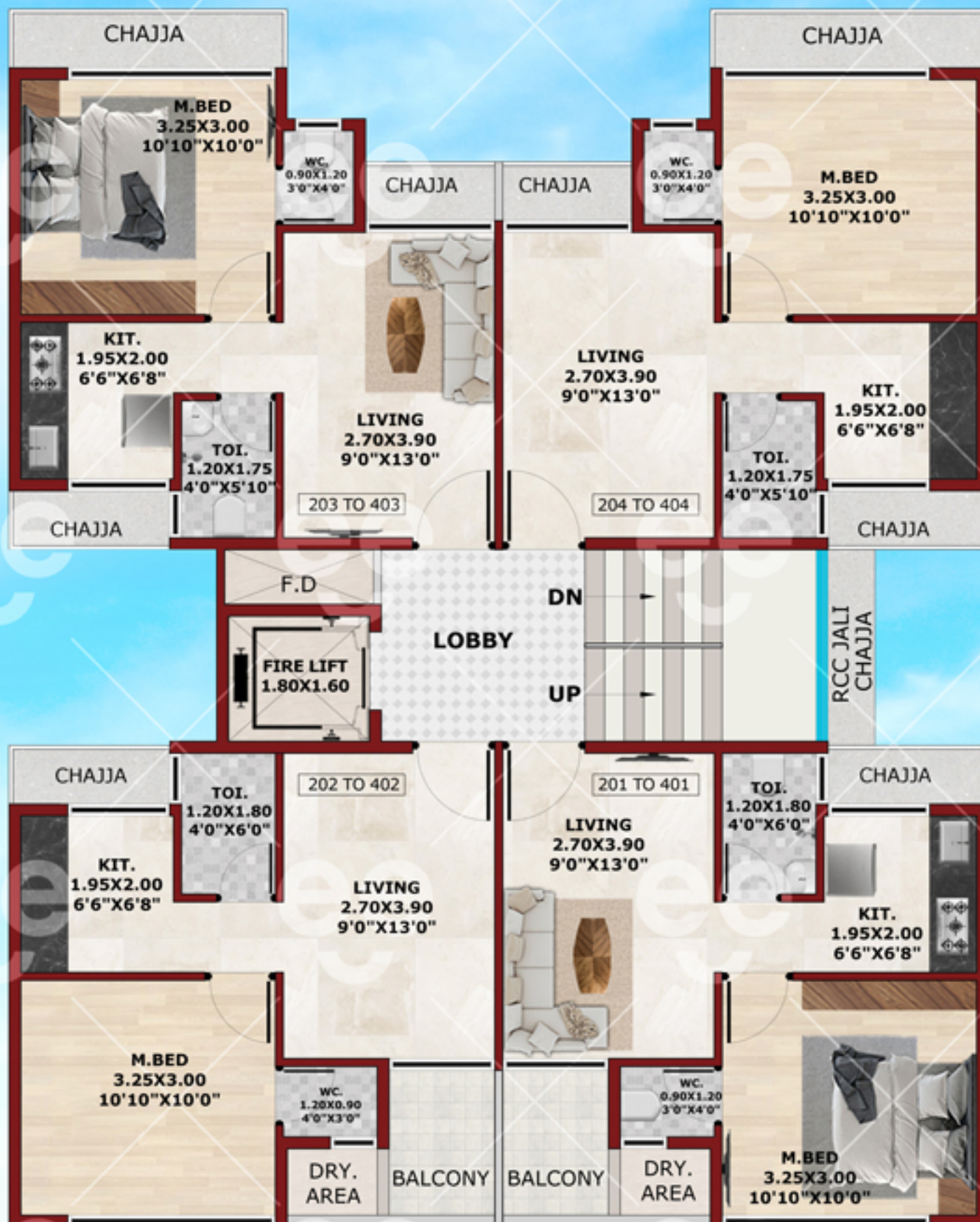


1st Floor Plan
